

# **A SPEECH BY H.E HON. JOHN OBIERO NYAGARAMA, GOVERNOR-COUNTY GOVERNMENT OF NYAMIRA ON REORGANIZATION OF COUNTY GOVERNMENT OF NYAMIRA**

Ladies and gentlemen welcome to this media briefing session

My government will be conducting several public participation Fora which are consultative and all inclusive to enhance provision of government information to the public, reporting mechanism and feedback from within and without with an aim of improving efficient and effective service delivery to county citizens.

Since inception of the Nyamira County Government we have seen increment in departments, entities and other relevant offices established legally with purpose of taking services to the public like; town administrators, Ward administrators, sub county administrators and county results office among others therefore emerging issues of coordination is critical to be addressed by reorganization of government to ensure all offices and office holders live to serve and strive to achieve the much expected results and even exceed to the advantage of mwananchi (kwamboka).

Today in exercising my mandate as dully elected Governor of Nyamira County, I wish to reorganize my government as below based on county organizational structure and Governor Circular No 1/2015

## **1. DEPARTMENT OF HEALTH SERVICES**

In addition to others previous duties in Governor Circular No 1/2013 will be in charge of; *sanitation services in all government buildings, offices, business premises, markets, open fields, stadiums etc*

## **2. DEPARTMENT OF AGRICULTURE, LIVESTOCK AND FISHERIES DEVELOPMENT.**

The duties will be as per governors circular No 1/2013

## **3. DEPARTMENT OF LAND HOUSING AND URBAN MANAGEMENT**

In addition to other previous duties in governor circular no1/2013 will be in charge of; *Town management Boards and administrators, infrastructural provision of all market amenities like construction of market stalls and toilets, fencing among others in liaison with public works*

#### **4. DEPARTMENT OF TRANSPORT, ROADS AND PUBLIC WORKS**

In addition to others previous duties in governor circular no 1/2013 they will deal with *traffic enforcement management of the county in terms of revenue and development control, construction of stadiums and playgrounds and provision of all required technical support to all county infrastructures development*

#### **5. DEPARTMENT OF FINANCE AND PLANNING**

The duties will be as per governors circular No 1/2013

#### **6. DEPARTMENT OF TRADE, INDUSTRY, TOURISM AND COOPERATIVE DEVELOPMENT**

- To enhance business database *collection, improve Cooperative relations and management, promote investment opportunities and explore news emerging best practices*
- *Promote cottage industry development*

#### **7. DEPARTMENT OF ENVIRONMENT, WATER, MINING, ENERGY AND NATURAL RESOURCES**

To deal with all duties of both previous to departments merged

#### **8. DEPARTMENT OF GENDER, YOUTHS, SPORTS, CULTURE AND SOCIAL SERVICES**

The duties will be as per governors circular No 1/2013

#### **9. DEPARTMENT OF EDUCATION AND ICT**

The duties will be as per governors circular No 1/2013

#### **10. DEPARTMENT OF PUBLIC ADMINISTRATION AND COORDINATION OF DEVOLVED UNITS**

- To provide humans resource management support mechanism to Head of public service in close consultation with County Governor to all departments, entities and sections within the county

- In charge of coordination of all administrative matters related to county departments, sub county administrators, Ward administrators and all devolved units
- To facilitate capacity program of planning, implementation and advisory skills services to county departments through county human resources advisory committee
- Stakeholders liaison county management services in consultation with governor

## **11. OFFICE OF THE GOVERNOR**

### County Results Office

- Co-ordination of all County Government projects undertaken by various entities
- Works closely with other chief officers and bring to the attention of the County Secretary on the implementation of polices and development plans
- Development and implementation of county intergrated strategic plan in liason with all stakeholders by facilitating effective public participation
- Formulate and implement effective programs to attain vision 2030 goals and sector goals
- Promote national values and principles of governance and of public services

The following County Executive Committee Members and County Chief Officers will be charged to deliver these envisaged results effective today 6/02/2014 as per the roles and responsibilities as outlined in the constitution of Kenya 2010, county government act, public management act and other laws, rules, regulations, manuals and policies issued from time to time from the Governor and other state organs.
