CHAPTER ONE

1.0 Introduction

1.1 Overview of the County

The County Government of Nyamira is one of the forty-seven devolved units established under Article 176(1) of the Constitution of Kenya, 2010. Its roles and responsibilities are defined in the Fourth Schedule, which assigns key functions such as health services, agriculture, trade development, and early childhood education to county governments

1.2 Legal Framework for Public Participation

Public participation is both a constitutional right and a legal requirement in Kenya's devolved governance system. Article 1(2) of the 2010 Constitution affirms that sovereign power belongs to the people, exercised directly or through elected leaders. Article 10(2) recognizes public participation as a core national value, while the Fourth Schedule, Part 2(14) assigns counties the duty of facilitating community involvement in governance and building local capacity.

The County Governments Act (2012) reinforces this through Section 87, which outlines key principles of citizen participation—openness, inclusiveness, accountability, and timely access to information. Similarly, the Urban Areas and Cities Act (2011, amended 2019) under Section 184 mandates public involvement in managing urban areas. Finally, Section 125(2) of the Public Finance Management Act (2012) requires the county finance executive to ensure citizen participation in the budget-making process.

To enhance transparency and ensure citizen involvement in the County Annual Development plan (CADP) 2026/27, the County Treasury conducted public feedback sessions on the draft CADP. This public participation exercise, which was also advertised in the local daily, was held on Monday, 24th September 2025, at the venues listed below.

1.3 Rationale for Public Participation in the FY 2026/27 CADP

Public participation is the engagement in governance whereby —people participate together for deliberation and collective action within an array of interests, institutions and networks, developing civic identity, and involving people in governance processes. The importance of public participation cannot be understated. Its contribution in anchoring democracy is significant as it ensures inclusivity and transparency in governance, as citizens and government agencies share power among themselves. It ensures government responsiveness to citizen needs and increases the legitimacy of government's decisions and institutions. Further, at the individual level, public participation increases patriotism, trust in public institutions, self-development, and commitment to the public good. This in turn increases social inclusiveness and social capital.

The main goals of public participation are to inform, engage, consult, collaborate and empower the citizenry. This occurs in different ways and environments, such as government, electoral, or civil society. However, the culture in public bureaucracy is not supportive of public participation, but leans on standard information exchange channels such as public hearing, which most of the times is one way and not oriented to problem solving, thus a there is need for transforming such culture and ensure that

citizens are partners and not just clients in governance through meaningful public participation.

Public participation in the integrated development planning (IDP) process is regarded as instrumental to promote partnerships between local government and communities in addressing local development priorities and concerns. The County Government Act Sections 94 and 95 provide that counties are to establish mechanisms to facilitate public communication and access to information with the widest public outreach using media.

1.4 Guiding Principles for FY 2026/27 County Annual Development Plan Participation

The identification and prioritization of community projects and programs for the financial year 2026/27 were guided by the following core principles:

- Equity and Social Justice: Efforts were made to ensure that the allocation of resources addressed existing inequalities and promoted inclusivity. Project prioritization aimed to reduce regional disparities by equitably distributing development initiatives across the two sub-wards per ward.
- High-Impact Interventions: Communities were guided to select projects with broad, long-term benefits. Emphasis was placed on initiatives that promise significant social or economic returns, serve a large population, or have a multiplier effect in improving livelihoods.
- Technical Soundness and Feasibility: Sector experts and technical officers at the county, sub-county, and ward levels provided professional input to ensure that community-proposed projects were viable, implementable, and aligned with budgetary limits and technical standards.

1.5 Objectives of the Public Forums

The main objectives of the County Annual Development Plan participation forums were to: Provide feedback on county achievements for FY 2023/24 to FY 2024/25

- Identify and map interventions supported by development partners
- Prioritize proposed projects and programs for FY 2026/27
- Facilitate community envisioning and planning for future development

CHAPTER TWO

2026/27 COUNTY ANNUAL DEVELOPMENT PLAN PUBLIC PARTICIPATION PROCESS AND METHODOLOGY

2.1 Introduction

This chapter addresses the participatory in Annual Development Plan preparing approach, covering the process, work plan, stakeholders, communication and mobilization framework, as well as a summary of attendance at the forums.

2.2 Public Participation Approach

The public participation process for fiscal year 2026/27 has adopted a new model, developed after evaluating the county's previous approach. This revised framework offers significant improvements based on past challenges and new opportunities for enhancing development and service delivery. A key feature of the new model is the integration of online platforms and physical submissions for project proposals, using sub-counties to gather feedback. This hybrid approach increases accessibility, encourages broader participation, and creates a more efficient public engagement process. The updated model is guided by key elements, including feedback from county departments on project implementation, support from development partners, and community activities where residents identify issues, create slogans, and set goals. It aligns community priorities with the County Fiscal Strategy Paper (CFSP) and ensures that budgets and projects reflect the community's needs, promoting relevant and effective development.

2.2.1 County Priority Focus Areas for Fy 2026/27

- Road maintenance-Ensuring that there is access to places across all ward through opening and murraming of roads
- Universal Healthcare- Strengthening healthcare infrastructure, enhancing service delivery, and ensuring access to quality medical care for all citizens.
- Youth Empowerment and Sports Development- Investing in sports, technical training, and entrepreneurship programs to equip youth with skills and opportunities that drive economic growth and foster self-reliance.
- Resource Mobilization, Fiscal Sustainability, and Private Sector Partnerships-Automating revenue collection, expanding revenue streams, and fostering partnerships to increase Own Source Revenue and ensure the County's financial stability.
- Decentralization of Services Empowering local service units to enhance accessibility, governance, and public participation at the grassroots level.

2.2.2 Public Participation Outputs/Community Priority Project and Programs

The table below summarizes the key projects proposed by communities during public forums held at the Sub-County level on 24th September 2025. It reflects priority needs across sectors like health, education, roads, agriculture, and water. The table captures citizens' calls for better

CHAPTER THREE:

CHALLENGES, LESSONS LEARNT AND RECOMMENDATIONS

3.1 Introduction

This chapter highlights the key lessons learnt, challenges encountered, and recommendations from the FY 2026/27 in County Annual Development Plan preparation

3.2 Challenges

Key Issues Identified During Public Participation Forums

- Venue Selection and Accessibility: Participants recommended that public participation forums be held at the ward level rather than the sub-county level to enhance inclusivity and accessibility.
- Inadequate Feedback Mechanisms: Community members expressed concern over the lack of consistent feedback from county entities regarding the outcomes of budget participation exercises.
- Time Constraints for Project Appraisal: There is insufficient time allocated for conducting thorough project appraisals and feasibility studies before implementation.
- Limited Community Capacity: Communities face capacity gaps in understanding and engaging with the participatory budgeting process effectively.
- Lack of Transparency in Priority Changes: Changes to community-prioritized proposals are made without proper citizen engagement, which has eroded public trust in the process.
- Delayed Project Completion: Some projects have remained incomplete for over a decade, such as Ekerenyo Hospital and Manga Stadium, raising concerns over resource management and accountability.
- Inadequate Representation: Not all wards were represented. For instance, Itibo Ward had no attendees, highlighting gaps in communication and early notification.
- Insufficient Reading Materials: Participants noted that reading and reference materials were not sufficient, limiting the effectiveness of participation.

3.3 Lessons Learnt

The key lessons learned from the public participation process were:

- Centralized venues limited attendance: Sub-County forums excluded many residents; ward-level meetings would improve access and participation.
- Lack of feedback reduced trust: Communities were not informed about how their input influenced decisions, lowering confidence in the process.
- Insufficient time for feasibility studies: Rushed timelines led to poor project assessments and unviable proposals.

- Low public capacity hindered participation: Limited understanding of budgeting processes weakened the quality of citizen input.
- Changed priorities without consultation: Altering proposed projects without engaging the public undermined transparency and trust.
- Long delays discouraged engagement: Incomplete projects like Ekerenyo Hospital and Manga Stadium demotivated citizens.
- Poor communication reduced representation: Late or limited announcements resulted in some wards (e.g., Itibo) being left out.
- Inadequate materials limited understanding: A Shortage of reading/reference materials made it difficult for participants to follow discussions.

3.4 Recommendations for the County Annual Development Plan preparation

The recommendations for the improvement of the participatory budgeting process in the future are:

- Strengthening Public Participation Structures: The county should enhance public participation by building capacity through ongoing training and regular community engagement.
- Capacity Development for Stakeholders: Targeted training should be provided for County Participatory Development Working Groups, Sector Working Groups, and Heads of Departments, focusing on participatory planning, budgeting, and integrating environmental and social safeguards.
- Improving Access to Information: The county should enhance information dissemination via websites, notice boards, media, and physical forums to promote transparency and informed participation.
- Financing Citizen Engagement: It is essential to fund civic education and public participation to ensure ongoing citizen engagement.
- Strengthening Decentralized Units: Decentralized units like sub-wards, wards, and subcounties should be strengthened as key centers for service delivery and citizen engagement.
- Including Vulnerable Groups: The county should create forums aimed at vulnerable and marginalized groups, such as women, youth, and persons with disabilities, to ensure their active participation in governance and development.
